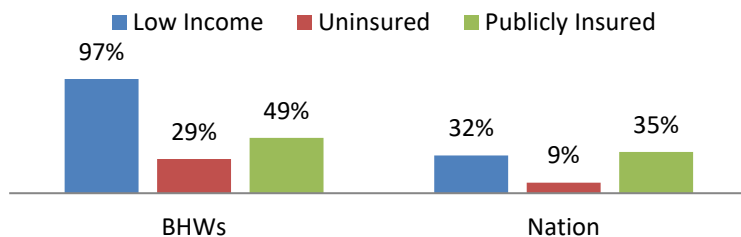
Bureau of Health Workforce Awardees: 2019 At a Glance

The Program

In calendar year 2019, 21 Bureau of Health Workforce awardees (BHWs) provided services to 20,702 patients with 69,112 visits. In the previous year (CY2018) there were a total of 38 awardees reporting.

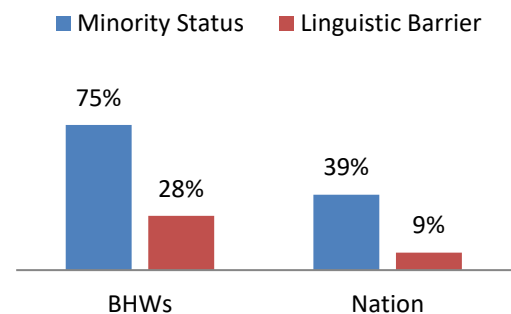
Patients: Socioeconomic Characteristics

- 97% of known incomes are at or below 200% of the Federal Poverty Level
- 29% are uninsured
- 49% have public insurance (Medicaid, Medicare, or Other Public)



Patients: Minority Status

- 75% are of racial and/or ethnic minority
- 28% face a linguistic barrier



Services Provided

- 76% of BHWs provide primary medical care services
- 0% of awardees provide dental services
- 86% of awardees provide behavioral health services

Continuity of Care

BHW awardees provide continuous care.

Staffing

BHW awardees employ the full time equivalent of 147 staff members and volunteers.

- 34 are physicians, CNMs, NPs, and PAs
- 36 are other clinical staff (nurses and other medical professionals)
- 14 are enabling service providers
- 0 are dental service providers
- 44 are behavioral health (mental health and substance use disorder)
- 30 provide non-clinical support

Virtual Visits

- 4 BHW programs (19%) utilized virtual visits
- 0.73% of all visits were virtual
- Virtual visits were most commonly used for mental health services at 0.81%

Quality of Care and Outcome Indicators: Clinical Performance

BHW awardees provide high quality of care. Measures that exceed Healthy People 2020 goals include low birth weight, hypertension control, and asthma. Other measures show room for improvement including early entry into prenatal care, cervical cancer screening, colorectal cancer screening, and controlled diabetes.

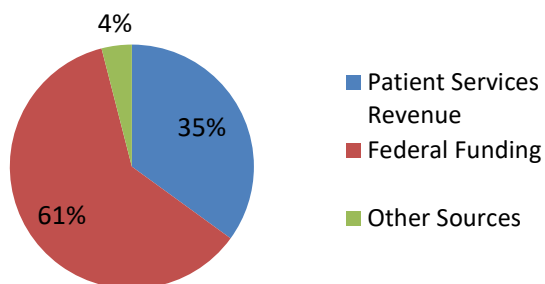

Sources of Support

BHWs are funded primarily through federal funding which includes HRSA BHW grant support.



Cost Effectiveness

- The average total cost per patient is \$586
- The average medical cost per medical visit is \$150
- The average charge per billable visit is \$137

Adjustments and Patient Discounts

- 68% of self-pay charges are written off as sliding discounts
- Indigent care funds cover 2% of self-pay charges
- 40% of insured charges are adjusted as allowances
